The online Building Permit System was developed by DSPS to allow municipalities to gain compliance with ACT 211. If you currently are applying for a New Single Family Dwelling, please click on the link below to start the process.

## Then click next, to Step 2:

Click on the License Lookup to bring up the contractor & it will prepopulate all the information in the boxes. You can do the same process for all contractors

## Click Next, Step 3:

This is where you need to enter all project location. It MUST have all information need to review the permit.

## Click, Next Step 4:

This is where you need to enter all project information to include sq ft., estimated cost, type of dwelling, energy source & other critical information.

## Click, Next Step 5:

Click that you accept, sign your name if it doesn't automatically show up. The date will automatically prepopulates in the form.

## Click Next, Step 6,

Review the information & click submit at the bottom

## Click Next, Step 7:

Print Confirmation for your records.
